

Hi Folks! On March 24, we had a revival meeting and sure enough there was a desire to keep the CRC as a viable entity within Skyline House. At the outset, the members reviewed the charter and purpose of the CRC and there was a consensus that to accomplish all the objectives would be taxing our capabilities at this stage of resurrection.

The Committee decided to focus three near term objectives. First, we will continue to maintain our received "Newcomers well Orientation" under the auspices of Tony DiSalvo. This program immensely beneficial in sharing knowledge with new tenants joining Skyline House family providing them with an orientation of the facilities not routinely seen, relating lessons learned on condo maintenance and providing the meet opportunity to Anyone wishing neighbors. assist Tony or accompany him on the orientation is heartily welcomed.

All ideas or thoughts are welcomed. Finally, are going to keep our opportunities alive with Nancy Harvey attending the Mason District Council meetings. We will keep you informed of local developments in the area as they become known and publicize that information in this newsletter.

Lastly, we plan to report on the status of owners and renters within Skyline House. The tally for 1988 is as follows: We had 78 move-ins to our buildings. Five of the 12 months there were no changes in the figures of renters and owners. However, in six of the months there was a plus of nine more owners than renters and in one month we had one more renter than owner. Thus, we had a net change during 1988 of eight new owners over renters. In the future, I hope to report on the total percentage of owners to renters.



PHYSICAL PLANT &
OPERATIONS COMMITTEE

For its first order of business, the 14 committee members expressed appreciation to Dantes York for his excellent service as co-secretary for the PPOC. Dan has resigned because he is moving. The Committee wishes him well in his new home. Dan shared the job with Rich Mundle, 1011W. Ray Malitzke, 1305W, has agreed to replace Dan.

A new maintenance log will constructed to try and make easier for everyone. The log will indicate when the work order was issued and completed. The Board will be requested to ask Management to: (1) place small notices in the mail lobby bulletin boards explain the operation of maintenance log, (2) consider sending a bulletin to each resident and (3) publishing an article in the management section of the "House Special."

The Chair was pleased to announce that Dave Harvey, 1605E, will continue as Board Liaison member to the PPOC.

The Committee again expressed concern that there appears to be no progress on correcting the rain leaks in the upper resdidential units of the East Building. PPOC recommended to the Board that it request the Property Manager to authorize Smith Company engineering (a service which is included in our management contract) to examine the problem and recommend a solution. PPOC also suggests consideration be given to hiring an outside architect or engineer who is experienced in these problems to review the Smith Company solution and offer any additional advice.



Whatever course of action is decided, the PPOC believes it should be initiated promptly to prevent further rain damage to residential units.

The PPOC also recommended to the Board that repairs to the fallen brick wall on the north side of the East Building be repaired as quickly as possible. The pile of rubble that once was a brick wall has lain untouched for months. The delay has been attributed to a settlement offer by the insurance company that is less than the insurance company's estimate to repair the damage. If an immediate and satisfactory settlement offer is not forthcoming from the Association's insurance agent, the Committee recommended that the Board prohibit the current insurance agent from bidding for the contract to renew the Association's insuranc coverage.

During new business, the alerted the Committee to the damage being done to the property not vandalism but also carelessness. The lawn and shrubbery beds are being destroyed in part by children on their way to and while waiting for the school buses. Adults also cause damage by walking through the shrubbery and then vaulting over the front walls. Also, there is damage from residents taking shortcuts to the Build shopping center. The damage considerable. Repairs are expensive and add unnecessarily to everyone's condominium fee. This topic scheduled to be discussed further the May meeting.

Finally, the Committee requested the Board ask the Property Manager to assure that: (1) the East Buildin


From Management

SWIMMING POOL OPENS MAY 27

The swimming pool will be open every day during the pool season, 11 a.m. to 8 p.m. except during inclement weather. Swimming pool passes will be available at the front desk after May 15. The number of passes issued for each unit will correspond to the number of people allowed to occupy a unit in the condominium By-Laws:

- 1 Bedroom 2 Passes 1 Bedroom/Den & 2 Bedrooms 3 Passes 2 Bedroom/Den & 3 Bedrooms 4 Passes
- A reminder of important swimming pool rules:
- 1. No food or drink is allowed inside the fenced in area of the pool food and drink must be consumed on the sundeck or park areas surrounding the pool.
- 2. No glass containers of any kind may be used on the sundeck or park area.
- 3. All persons are requested to shower and enter the pool thru the bathhouses. You may not enter thru the double doors to the sundeck during pool hours.
- 4. It is suggested that you use ear plugs if you wish to listen to a radio. If not using ear plugs, you are requested to keep the volume low enough not to disturb others.
- 5. Children under 12 must be accompanied by an adult (over 18) during the entire time they are in the pool area.
- 6. Robes or other suitable garments and shoes must be worn to and from the pool area.

- 7. Please use the G level corridors to and from the pool area. Please do not go thru the lobby.
- 8. ABSOLUTELY NO DIVING.



BALCONY ETIQUETTE


It's springtime again and many residents will be using their balconies. We remind you of:

RULE 15. BALCONIES-PATIOS & WINDOW!

- A) Laundry, clothing, rugs or other items are not to be hung on or upon the exterior of buildings.
- B) Clothes lines, clothes racks or any other similar devices may not be used to hang any items on any balcony, patio or window.
- C) Unit Owners/Residents shall not throw anything out of the windows or from balconies or patios.
- D) Shaking of mops, brooms or other cleaning materials from the balconies, patios or windows is NOT permitted.
- E) Flower boxes, if attached to the railing, must be on the inside of the railing and securely fastened.
















RECREATION COMMITTEE

PROM MANAGMENT (continued)

Awnings, blinds, shades, screens and like items and appurtenances, except window screens as installed by the developer, shall NOT be installed by any Unit Owner/Resident beyond the confines of his/her unit without prior written consent of the Association Board of Directors. (The balcony or patio associated with a unit is considered beyond the confines of that unit.)

- G) Balconies and patios shall NOT be used for storage.
- H) Bicycles may NOT be stored on balconies or patios.
