MASON DISTRICT NEWS:

VDOT's Snow Removal Standard Procedures: In Northern Virginia, the Virginia Department of Transportation (VDOT) is responsible for clearing

snow and ice on more than 16,000 lane miles of road in Arlington, Fairfax, Loudoun, and Prince William Counties. VDOT's general standard for snow removal is to plow interstate highways and major primary and secondary roads, within 12 to 18 hours after the storm stops, depending on the severity of the storm. Snow removal crews will try to plow lower priority routes, including subdivision roads, within 48 hours after the storm stops. VDOT may be contacted 24-hours a day through the duration of a winter storm by phone at 703-383-VDOT (8368),or by e-mail novainfo@vdot.virginia.gov. information For about road conditions in Northern Virginia, call 703-383-VDOT (8368), 24-hours a day. For information about road conditions in other parts of the state, call 1-800-367-ROAD (7623). TTY users may call 1-800-432-1843.

Fairfax County Health Department operates five centers in the county and serves county residents and others who live in Falls Church and Fairfax City. The program is designed to meet the needs of adults with physical, memory, and other cognitive limitations. It is an excellent choice for:

- Adults who need care, yet wish to continue living at home and stay within the community;
- Families who work and cannot leave their relative home alone during the day and caregivers who need respite.

- Saturday 9:00 a.m. 12:00 noon.




Covenants Committee Joseph Livingston, Chairman

The outside part of your dryer vent (above the balcony door) must be cleaned prior to any duct cleaning for your dryer by the contractor. If you live in tiers 5, 6, or 14, your dryer vents are out above your dining room window and are not accessible. These vents will be cleaned by our contractor during the next few days. All others should call the Management office to schedule the outdoor part of the vent (above the balcony door) to be cleaned by our staff, prior to the cleaning of the interior ducts.
