

We, in the Management Office, wish everyone a Peaceful and Happy New Year.

2007 was a good year for Skyline House except for the noise disturbance experienced by the East Building residents, generated by the Façade Repairs which unfortunately could not be avoided. Our goal continues to be the preservation of your assets at the highest level possible.

I personally want to thank Greg, the Association's Chief Engineer and his assistant, Tettie, and Betty, the Association's Housekeeping Supervisor and her assistant, Gerardo, for the constantly excellent performance of the Maintenance, Painting and Housekeeping staff whom they work with and supervise.

The following major items were accomplished during 2007:

- Installation of the Access Control System (key fobs)
- Front Circle Drive Renovation
- East & West Parking Lots Asphalt Resealing
- Painting of the Garage B & C Level Ceiling Beams
- Painting of all Unit Entrance and Common Area Doors
- Completion of Fourth and Final Phase of the 4-year Façade Repair Project
- East Building Landscaping Rehabilitation

The following major items are planned and budgeted for 2008:

- Replacement of the Energy Management System
- Repair/Replacement of West and East Party Room Flooring and Sound Insulation
- Front Circle Landscape Rehabilitation
- Rewiring of the Buildings for Upgraded TV Cable Transmission
- Garage Concrete Repairs and Sealing of Elevated Decks
- Replacement of the Lobby and Connector Corridor Roof
- Replacement of the East and West 1st Floor and Gallery Carpeting

ALL BIKES MUST BE REMOVED FROM BIKE ROOMS BY SUNDAY NIGHT JANUARY 13, 2008

The East and West Bike Rooms will be renovated during the **third** week of January 2008. All bikes stored in these rooms must be removed by **Sunday night**, **January 13**, **2008**. The bike rooms will reopen on Friday afternoon, January 18th. The renovation will modify the existing bike racks offering improved support for the bikes. New registration will be mandatory. This last measure is necessary due to the fact that during the third weekend of November two bikes and one tire were reported stolen from the West Bike Room. The combination locks for these rooms have been recoded and will be routinely recoded on a monthly basis. New codes will be given from the Front Desk only to residents who have a bike registered for the room.

Applications can be picked up at the front desk.


Return completed applications to the Management Office on or before close of business Friday, February 8, 2008.
